Guest Speaker: Sallie Taylor for the Blue Zone Initiative

A handout on the Blue Zones Project was provided to the commissioners with their agenda packet. Ms. Taylor outlined Blue Zones as being identified by Dan Buettner as places where people live measurably longer, happier and healthier lives with lower rates of chronic disease and higher quality of life. Nine characteristics were noted as part of this lifestyle. Ms. Taylor will be hosting a presentation with a Q&A session with Mr. Buettner on Monday, June 10 beginning at 5:00 p.m. at the Performing Arts Center in Highlands. ### Mayor's Report:

- Rain is forecasted for the community workday on Saturday, so she would like three people to make the decision as to canceling it on that morning. A notice will be placed on the facebook page if it is canceled or postponed. Justin Woodard reported finding hypodermic needles in the mulch there this week, so everyone attending the workday should use caution and bring gloves. Mayor Rodes is continuing to work on securing permission for underground hard-wiring for lighting at that location.
- A benefit for Annalise Davis, who is battling cancer will also be held Saturday at the Jackson County Recreation Center or at Cullowhee Valley School in the event of rain.
- Commissioners are encouraged to contact their legislators to oppose two bills, HB 645/SB 534 Revisions to Outdoor Advertising Laws, and HB 278/SB 179 Parity for First Responders. Public input does help inform our elected officials' votes on these issues.
- Mayor Rodes requested that town business that is not an emergency be handled between the hours of 10 a.m. and 7 p.m. Monday through Saturday. For emergencies, please call her cell or publicly listed home phone number.

## **Council Members' Reports:**

Commissioner Young stated that the Planning Board will meet next Tuesday night. The Greenway Meeting will meet tomorrow. Commissioner Young has also made a trip to County Roads Farm to investigate plant options for the Grant Project.

1.	Budget Review for the 2019-2020 Proposed Budget: Mayor Rodes would like to see the \$1,000 donation to the Cemetery and the \$1,000 donation to Jackson County Rescue Squad moved from the Residential Services category. The purpose is to increase transparency and also to clarify that these are not residential services that the Town is invoiced for or is responsible for, but that they are charitable in nature. Several options were discussed included moving all donations to GOV Miscellaneous Expenses or creating a new line item for GOV Charitable Contributions. It was the consensus of the board to move all contributions to GOV Miscellaneous Expenses. The board consensus was to continue to budget for other usual annual memberships such as Circles of Hope, the Chamber of Commerce, and the Jackson County and Webster Historical Societies.
